## FISCAL YEAR 2025 IAA MEMBERSHIP CATEGORIES & DUES SCHEDULE

### I. COMMERCIAL PRODUCER - Only

Persons, organizations, or corporations engaged in aquaculture in Idaho for the purpose of profit. Commercial Producer members have one vote in IAA. One partnership, one corporation, one individual, or two or more corporations in which the majority stock is owned by one individual, constitutes one membership. Operators leasing facilities should pay based on the cumulative total volume of water licensed or permitted from all farms leased and shall have one vote.

**Dues for Commercial Producers are based on licensed, permitted, or average water flows in CFS.**

**Commercial Producer dues:** \$12 per CFS (\$120 minimum/ \$240 maximum)

### II. COMMERCIAL PROCESSOR - Only

**Dues for Processors are based on the following production scale:**

<100,000 lbs. processed:	\$ 120 minimum
>100,000 processed:	\$ 240 maximum

Government Agencies, Colleges, Universities:	\$240
